2014 Canadian Income Survey (CIS)



A new data cycle for the Canadian Income Survey (CIS) has just been released; information for 2014 is now available.

The Canadian Income Survey (CIS) provides information on the income and income sources of Canadians, along with their individual and household characteristics. The data collected in the CIS is combined with Labour Force Survey (LFS) and tax data.

The survey gathers information on labour market activity, school attendance, disability, support payments, child care expenses, inter-household transfers, personal income, and characteristics and costs of housing. This content is supplemented with information on individual and household characteristics (e.g. age, educational attainment, main job characteristics, family type), as well as geographic details (e.g. province, census metropolitan area (CMA)) from the LFS. Tax data for income and income sources are also combined with the survey data.

The Canadian Cancer Registry (CCR) 2011 to 2013



The Canadian Cancer Registry (CCR) data, updated with years of diagnosis 2011-2013, are now available for download and can be accessed by researchers with approved projects for "Canadian Cancer Registry (CCR) - all available years".

The CCR is an administrative database that collects information on cancer incidence from all provincial and territorial cancer registries in Canada. The CCR is a dynamic database of all Canadian residents, alive or dead, who have been diagnosed with cancer since 1992. The CCR is a patient-based system that records the type and number (incidence) of primary cancers diagnosed for each person until death. Subsequent primary cancers occurring for patients who are already in the database are linked to their existing patient information.



Updated: Canadian Census Health and Environment Cohort (CanCHEC)



Updated data for the Canadian Census Health and Environment Cohort (CanCHEC), originally known as the Canadian Census Cohort Mortality and Cancer Follow-up Study, is now available. New data, for 1991, are now available.

Changes to the data include:

- The addition of mortality follow-up from January 1, 2007 to December 31, 2011
- The addition of postal codes for 1981, 1982 and 1983 tax years
- Based on subsequent data quality analysis, Subject Matter reduced the Cohort size from 2,374,835 to 2,644,370.
- Consistency checks between the different linkages (e.g. cancer, mortality, tax) resulted in some cancer and mortality links being dropped, especially between the 1991 to 2001 period
- Additional cause of death information is now available for some tax only deaths
- The coding for some variables have changed or have been removed. Please refer to the data dictionaries

Researchers who already have access to Canadian Census Cohort Mortality and Cancer Follow-up Study may or may not want to update their analysis with these new files. If researchers want access to the new data, an amendment to add the data is required.
